EXPRESSION OF INTEREST

The Expression of Interest is invited from the agencies/firms/parties individuals to provide medical services to the registered building and other construction workers at their door-steps/construction site through mobile dispensary vans with one Medical Officer having qualification MBBS or BAMS including one Pharmacist, one Driver and one Stretcher-Server for each mobile dispensary van in the areas of Districts Ambala, Yamuna Nagar, Panipat, Sonipat, Hisar, Rohtak, Gurgaon, Faridabad, Rewari and Narnaul, for a period of one year, which will be expendable keeping in view the performance of the agency/firm so selected.

The agency should have an experience of successfully executing and completing the similar type of scheme during the last three years ending 31.3.2010 under any Government Department/Boards/Corporations.

OTHER TERMS AND CONDITIONS

- POL and Maintenance of vehicles will be the responsibilities of the agency.
- The vehicle will be used as a Mobile Medical Van with one Doctor and Paramedical staff alongwith stock of medicines for providing medical facilities at various construction sites and residential colonies of these workers.
- Medicines will be supplied by the Board.
- Alternative vehicle with Driver would have to be provided when existing vehicle is withdrawn for repairs etc. or is off road.
- The duties hour will be from 11.00 A.M. to to 8.00 P.M.
- The vehicle will be used on all week days except Sunday.
- In case of failure to provide alternative vehicle with Driver, a sum of Rs.1,000/- per day would be deducted from monthly contracted amount without notice.
- Vehicle would be used for a maximum of 2000 Km. per month, excess kilometer run would be paid extra at the maximum rate of Rs.6/- per kilometer.
- Toll tax, if any, will be paid by owner/agency.

Note: Agencies/Firm/Parties/Individual can apply for single district as well as for all stations.
